- We have predominantly **localized** trafficking; the victims and the demand are generally from this area. This might be evidenced by an established prostitution track, erotic massage parlors, strip clubs, military base.
- We are predominantly a trafficking **pass-through**; victims may be local or may come into our area for a time and then move on. This might be evidenced by web ads with promotions of short stays, being located on a major thoroughfare, truck stops, erotic establishments located along the highway.
- We are predominantly a trafficking **destination**; victims may be local or may come into our area, but the demand comes into our area for exploitation. This may be evidenced by a high level of tourism, beaches, conventions, sporting events, seasonal activities such as carnivals or major festivals (eg, Mardi Gras).
- We don't have any sense of the pattern of trafficking in our area.
